A. THE RELEASE OF 2019 GRADE 12 RESULTS

1. VERIFICATION OF RESULTS

Principals / schools will not be involved in the verification of results on 26 and 27 December, in Mmabatho by Corporate and District officials. Principals are requested to be on stand by as where there is any doubt, principals will be contacted on their cell phones.

2. RELEASE AND DISTRIBUTION OF RESULTS

On 8 January 2020 at 09:00, the Honourable MEC, Mmaphefo Lucy Matsemela will release the 2019 NSC Grade 12 results during a press conference.

For the smooth distribution of results to every examination centre, the following arrangements have been made:

2.1 District Examination and Assessment Managers (DEAMs) and an official from each District office should arrange for the collection of statements of results on 6 January 2019.

The DEAMs for Bojanala Platinum, Dr. Kenneth Kaunda District. Ngaka Modiri Molema and Dr. Ruth Segomotsi Mompoti Districts to arrange with Mr. PAG Gill for collection in Mafikeng.

- 2.2 Every person handling, collecting or distributing statements of results will have to sign acknowledgement letters and confidentiality forms when handing over takes place. The DEAMs have to file all these forms.
- 2.3 The statements of results will be distributed to the Sub District offices on 7 January 2020 through the relevant officials, as indicated in the attached organogram. Principals may collect the results from the Sub District Offices from 15:00 and should sign a confidentiality agreement which states that no results of the school will be made known to anybody before 08:00 on 8 January 2020.

Sub District Managers will make arrangements with Sub District Examination Officials for collection at the District office on 7 January 2020 and thereafter the schools will collect from their respective Sub District Offices on 7 January 2020 **from 15:00**.
- 3.2 Dr Kenneth Kaunda District
Mr. GM Moseki will collect all the results for the four sub districts offices. Sub District Managers will make arrangements with Sub District Examination Officials for collection at the District office on 7 January 2020 and thereafter the schools will collect from their respective Sub District Offices on 7 January 2020 **from 15:00**.
- 3.3 Dr Ruth S. Mompati District
Mr. J Brand will collect all the results for the three sub districts offices. Sub District Managers will make arrangements with Sub District Examination Officials for collection at the District office on 7 January 2020 and thereafter the schools will collect from their respective Sub District Offices 7 January 2020 **from 15:00**.
- 3.4 Ngaka Modiri Molema District
Mr. KP Nyamane will collect all the results for the five sub districts offices. Sub District Managers will make arrangements with Sub District Examination Officials for collection at the District office on 7 January 2020 and thereafter the schools will collect from their respective Sub District Offices on 7 January 2020 **from 15:00**.

B. NSC 2020 MAY/JUNE EXAMINATION

1. All candidates for 2019 NSC examination who wish to write in May/June 2020 examination will receive an entry form that will be released with the results on the 8 January 2020 to fill.
2. Candidates may be placed at central venues in each Sub District office (Entry forms will be distributed with the statements of results and principals should sign registration forms).
3. Closing date for entries is **31 January 2020**.
4. No **late entries** will be accepted.
5. A copy of the 2019 results **MUST** be attached to the entry form.

6. Conditions for registration will be printed on the back of the statements of results.
7. No entry form will be processed if the required original documents are not attached and no form will be captured if submitted after **31 January 2020.**



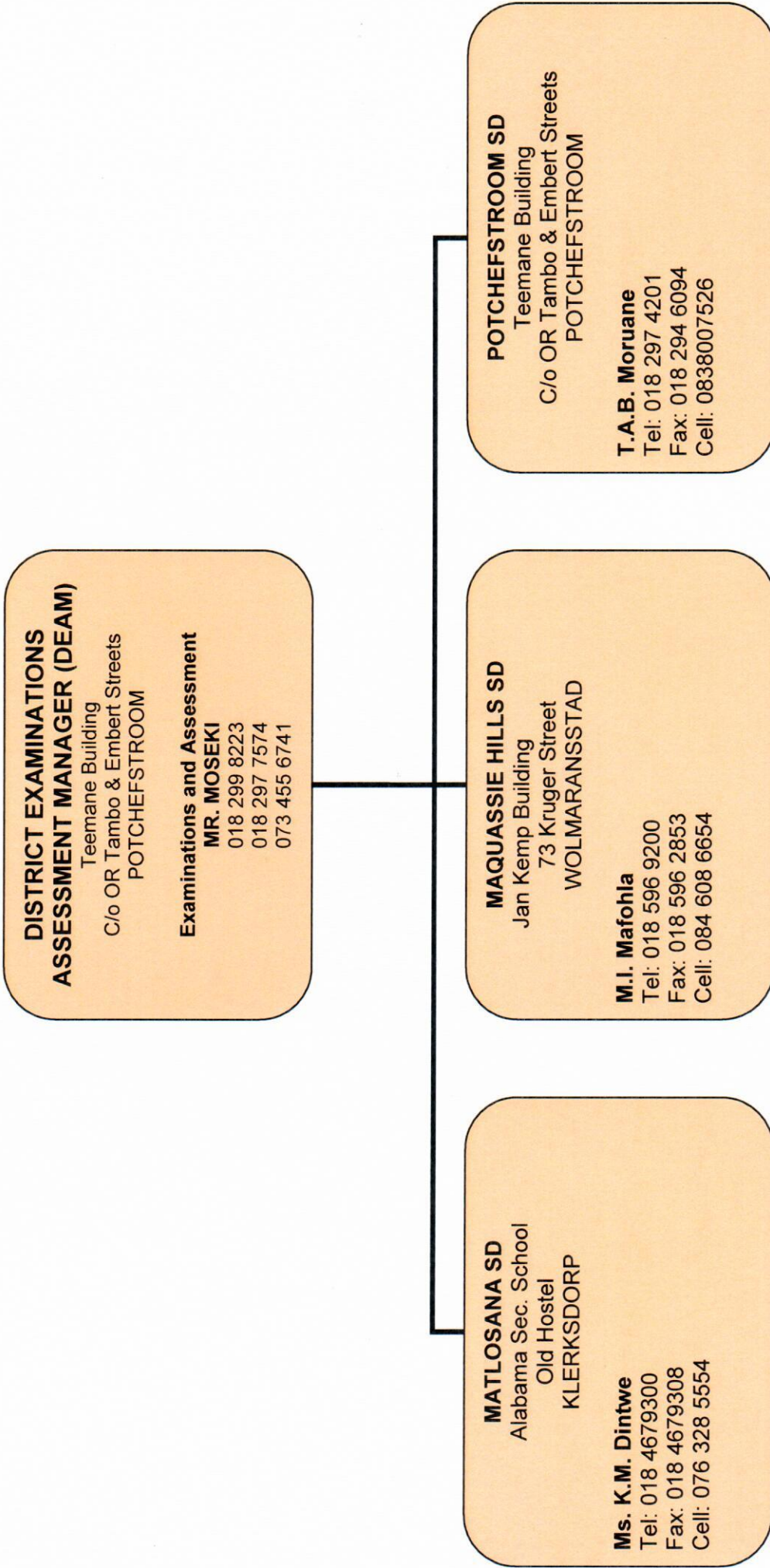
