SECTION A: SOURCE-BASED QUESTION**QUESTION 1: WHY DID FOREIGN COUNTRIES DECIDE TO GET INVOLVED IN ANGOLA AFTER 1975?**

Study Sources 1 A, 1 B, 1 C and 1 D and answer the questions that follow.

1.1 Read Source 1 A.

- 1.1.1 List any TWO Angolan liberation movements from the source. (2 x 1) (2)
- 1.1.2 Define the historical concept *anti-colonial war* in your own words (1 x 2) (2)
- 1.1.3 Why, do you think, was there a 'furious (violent) war for power in Angola' after 1975? (2 x 2) (4)
- 1.1.4 Using the information in the source and your own knowledge, explain how the USA and the Soviet Union became involved in the Angolan Civil War. (2 x 2) (4)

1.2 Consult Source 1 B.

- 1.2.1 What according to Neto, motivated the MPLA to ask Cuba for help? (1 x 2) (2)
- 1.2.2 Quote TWO forms of assistance, from the source that the MPLA requested from the Cuban government. (2 x 1) (2)
- 1.2.3 What type of political ideology, according to the information in the source, did Cuba adopt after 1959? (1 x 2) (2)
- 1.2.4 Using the information in the source and your own knowledge, explain why you would consider the information in this source useful when writing about Cuba's involvement in the Angolan Civil War. (2 x 2) (4)

1.3 Study Source 1 C.

- 1.3.1 Name TWO items from the source that Cuba sent to the MPLA on 5 November 1975. (2 x 1) (2)
- 1.3.2 Why, according to the source, did the MPLA request assistance from Cuba? (1 x 2) (2)
- 1.3.3 Explain how Castro viewed his relationship with the Soviet Union and the MPLA. Support your answer by using the information in the source and your own knowledge. (2 x 2) (4)



- 1.3.4 Comment on Castro's opinion of Presidents' Ford and Kissinger regarding Cuba's role in Angola. (2 x 2) (4)
- 1.4 Use Source 1 D.
- 1.4.1 Why did Henry Kissinger justify the USA's involvement in the Angolan Civil War? Refer to Frames 1 and 2 in the cartoon to support your answer. (1 x 2) (2)
- 1.4.2 Explain how Kissinger responded to President Ford regarding the civil war in Angola. Refer to Frame 3 to support your answer. (1 x 2) (2)
- 1.5 Compare Sources 1 C and 1 D. Explain how the information in Source 1 C differs from the evidence in Source 1 D regarding the involvement of both Castro and Kissinger in Angola. (2 x 2) (4)
- 1.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words), explaining why foreign countries decided to get involved in Angola after 1975. (8)
